



Business Description

Making Science Group SA is engaged in the business of technology and marketing solutions for the digital business. The company provides solutions in areas of digital marketing, data analytics, e-commerce, and cloud. The company carries out its professional activity in 10 countries: United States, Spain, Portugal, Ireland, Georgia, Italy, France, United Kingdom, Mexico, Colombia. The Company obtains its income mainly from advertising and public relations services.

Valuation as of 16 May 2024

Morningstar affirms a 3-star quantitative rating for Making Science Group. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 9.00, a discount of 22.09% to its Quantitative Fair Value estimate of 11.55. This discount has ranged between 48.3% and 15.33% over the past year. The stock's price to fair value ratio is at the 50th percentile in our global equity coverage universe for this methodology and at the 56th percentile relative to its peers in the communication services sector.

Making Science Group furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Extreme to Very High after 01/17/2024.

We examine the financials and market statistics for Making Science Group to determine these ratings. Its enterprise value-to-market value ratio is 1.54 and its trailing 12-month maximum drawdown is 25.89%. These fall at the 79th and 44th percentiles in the equity universe and at the 76th and 42nd in the communication services sector, respectively.

Economic Moat ^Q as of 16 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.82 sits at the 79th percentile in the communication services sector. This is a decrease from 0.86, the maximum of its moat scores over the past year.

The quantitative financial health rating for Making Science Group is Moderate. Its financial health score, termed Distance to Default, sits at the 30th percentile in the universe and 32nd percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Making Science Group is 11.57%, and its annualized trailing 12-month volatility is 28.55%. They sit at the 13th and 42nd percentile in the global equity universe, respectively.

Fundamentals as of 16 May 2024

The earnings per share for Making Science Group is -1.06. The company earns a return on invested capital of -9.24%, falling at the 19th percentile in the communication services sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, the company's priceto-free cash flow ratio is 72.98, greater than 93% of its sector peers. These values are calculated using the stock's price at last market close.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. - i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.
