



#### **Business Description**

Biotechnology Assets SA is a clinical-stage biopharmaceutical company developing and producing biological products for the pharmaceutical and veterinarian sectors. It specializes in the prevention and treatment of niche diseases, such as orphan disease, antigens for new-generation vaccines, feed additives, and probiotics. Adl Bionatur offers a portfolio of non-therapeutic and therapeutic products to tier 1 and tier 2 animal health companies. The company's pipeline products include BNT006, BNT007, BNT010, and others.

### Valuation as of 17 May 2024

Morningstar affirms a 3-star quantitative rating for Biotechnology Assets. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 0.34, a discount of 27.99% to its Quantitative Fair Value estimate of 0.48. This discount has ranged between 50.87% and 20.03% over the past year. The stock's price to fair value ratio is at the 39th percentile in our global equity coverage universe for this methodology and at the 58th percentile relative to its peers in the healthcare sector.

Biotechnology Assets furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 05/14/2024.

We examine the financials and market statistics for Biotechnology Assets to determine these ratings. Its earnings yield is 7.95% and its sales yield is 18.19%. These fall at the 80th and 24th percentiles in the equity universe and at the 94th and 43rd in the healthcare sector, respectively.

### Economic Moat <sup>Q</sup>as of 17 May 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Biotechnology Assets falls at the 35th percentile in both the healthcare sector and equity coverage universe. The company has maintained its None quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Biotechnology Assets. The company's raw score on this metric, termed Distance to Default, ranks at the 21st percentile overall and 24th in the healthcare sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 33.75%, ranks at the 32nd percentile in the covered equity universe and at the 51st percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 38.29%, falls at the 60th percentile in the universe and the 40th percentile in the healthcare sector.

### Fundamentals as of 17 May 2024

The earnings per share for Biotechnology Assets is 0.03. The company earns a return on invested capital of 16.55%, falling at the 92nd percentile in the healthcare sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Biotechnology Assets holds a price-to-earnings ratio of 12.58, a figure greater than 16% of its sector peers.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
