



Business Description

Alquiber Quality SA provides vehicles on rental basis. The company offers cars, trucks, vans, SUV's, and pick-ups vans.

Valuation as of 17 May 2024

Morningstar affirms a 3-star quantitative rating for Alquiber Quality. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 10.50, in-line with its Quantitative Fair Value estimate of 10.38. The stock has been trading between a 21.12% discount and 4.02% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 90th percentile in our global equity coverage universe for this methodology and at the 84th percentile relative to its peers in the industrials sector.

Alquiber Quality furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 10/06/2023.

We examine the financials and market statistics for Alquiber Quality to determine these ratings. Its earnings yield is 3.08% and its trailing 12-month maximum drawdown is 6.31%. These fall at the 53rd and 5th percentiles in the equity universe and at the 42nd and 5th in the industrials sector, respectively.

Economic Moat as of 17 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Alquiber Quality falls at the 85th percentile in the industrials sector and at the 90th in the equity coverage universe. The company has maintained its Narrow quantitat-

ive moat rating for the last year.

We also assign a Strong quantitative financial health rating to Alquiber Quality. The company's raw score on this metric, termed Distance to Default, ranks at the 89th percentile overall and 91st in the industrials sector. Furthermore, this financial health rating most recently changed from Moderate after 08/04/2023.

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 20.01%, ranks at the 20th percentile in the covered equity universe and at the 19th percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 9.32%, falls at the 5th percentile in both the universe and the industrials sector.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
