



#### **Business Description**

Proeduca Altus SA is engaged in the business of providing online education. The business has its presence in Spain, Ecuador, Colombia, Mexico, Peru, Argentina, Bolivia and the USA.

### Valuation as of 17 May 2024

Morningstar maintains a 2-star quantitative star rating for Proeduca Altus, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 20.20, above our quantitative fair value estimate of 16.38. These shares have traded between a 4.76% discount and 23.29% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 95th percentile; in the consumer defensive sector, the firm's score lies at the 95th percentile (meaning the shares are more undervalued than 95% of stocks in the sector).

Furthermore, Proeduca Altus maintains a quantitative valuation uncertainty rating of High.

The company has held this star rating since the previous rating of 3, which was last assigned on 04/18/2024. The uncertainty rating for Proeduca Altus has remained High over the past year.

The key factors behind these ratings are the company's EV-MV ratio and volatility. The enterprise value-to-market value ratio is 0.91, and its maximum annualized trailing 12-month volatility is 18.84%. The EV-MV ratio falls at the 15th percentile in the consumer defensive sector while the volatility is at the 30th percentile. Over the past year, the company's EV-MV ratio has been between 0.89 and 0.94; its volatility has ranged between 14.18% and 18.84%.

With a Narrow Morningstar quantitative moat rat-

ing, the quantitative moat score for Proeduca Altus falls at the 94th percentile in the consumer defensive sector and above the 95th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating since after 05/15/2024, when it was downgraded from Wide.

We also assign a Strong quantitative financial health rating to Proeduca Altus. The company's raw score on this metric, termed Distance to Default, ranks at the 90th percentile overall and 94th in the consumer defensive sector. Furthermore, this financial health rating has stayed Strong over the last year

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 1.04%, ranks at the 7th percentile overall and among its peers. Meanwhile, its annualized trailing 12-month volatility of 18.71%, falls at the 17th percentile in the universe and the 30th percentile in the consumer defensive sector.

### Fundamentals as of 17 May 2024

Proeduca Altus maintains earnings per share of 0.77. The company further earns a return on invested capital of 247.48%. The shares offer a dividend yield of 6.13%. These values are calculated over a trailing 12-month period.

As of last market close, Proeduca Altus has a price-to-earnings ratio of 26.12, falling below the 67th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 21.59 and 27.65 over the past year. The company's price-to-free cash flow ratio is 16.33, falling at the 54th percentile in its sector and ranging between 13.5 and 19.9 over the past year.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
